

## Ohio Health and Human Services Eligibility Modernization Design and Implementation Timeframe

(updated June 4, 2012)

The Governor's Office of Health Transformation (OHT) initiated an eligibility modernization initiative to simplify client eligibility based on income, streamline state and local responsibility for eligibility determination, and modernize eligibility systems technology. Taking these actions will improve the consumer experience and significantly reduce costs. OHT will seek enhanced (90/10) federal funding, which is available to states to upgrade eligibility systems for Medicaid and related health and human service programs. The goal is to design and competitively procure a new system prior to the federally-mandated eligibility expansion in January 2014.

Given the urgency to act prior to 2014, Ohio is proposing the schedule shown below to simplify and modernize the state's health and human services eligibility systems, including Medicaid. This schedule will be updated as additional activities and dates become available and are approved by the federal government. More information about this initiative is available on the OHT Website:

Q2-Q4 2012	Ongoing operational and infrastructure planning, release a request for proposals (RFP), and competitively select a vendor to operate the new system	
Q2 2012	Planning begins for acquisition strategy, risk analysis, alternatives analysis, scope definition, business requirements, performance measures, OAC rules to clearance	
Q3 2013	Joint Committee on Agency Rule Review (JCARR) considers OAC rule changes	
Q3 2013	OAC rules in effect, all contracts and agreements in effect, and system testing begins	
Q3 2013	Outreach and training, and user acceptance testing begins	
Q3 2013	The new system begins accepting applications	
Q1 2014	The new system is operational
