

Nursing Home Franchise Fee Announcement

- The Ohio Department of Job and Family Services Office of Ohio Health Plans (Medicaid) has determined that the SFY 2011 franchise fee assessment for nursing homes and hospital long-term care units exceeded the federal limit of 5.5 percent of net patient revenue.
- This overage occurred because the state established the SFY 2011 franchise fee assessment rate based on a percent of *estimated* net patient revenue to nursing facilities. The *actual* SFY 2011 net patient revenue to nursing facilities (based on a correction in how hospital-based units reported revenue) was less than estimated.
- When the state collects more than the allowable amount of franchise fee revenue, it is required to issue a refund in the first quarter of the next fiscal year, per ORC 3721.51(C).
- Nursing facilities were originally assessed a SFY 2011 franchise fee rate of \$12 per bed day, which has been recalculated to a rate of \$11.35 per bed day. Facilities with more than 200 beds were originally assessed a SFY 2011 rate of \$9.81 per bed day for beds in excess of 200, which has been recalculated to \$9.28 per bed day for beds in excess of 200.
- Ohio Medicaid will send the SFY 2012 franchise fee assessment notice to nursing facilities on October 3 and include a notice of the recalculated franchise fee for SFY 2011. A refund of the SFY 2011 overpayment will be reflected as a reduction in the amount of each facility's SFY 2012 first-quarter installment payment that will be due by December 15.
- The total amount of the SFY 2011 refund for all nursing facilities is \$22 million.

Dear Administrator:

The state fiscal year 2012 franchise permit fee (FPF), in accordance with Ohio Revised Code (ORC) Section 3721.53, is to be determined by September 15, 2011 and the assessment notice mailed by October 1, 2011. In accordance with sections 3721.50 to 3721.58 of the ORC, the nursing home FPF assessment was determined based on the number of licensed, certified, or registered beds on May 1, 2011, as reported by the Ohio Department of Health. In accordance with the waiver approval implemented July 1, 2010, ORC Sections 3721.51 and 3721.512; the franchise permit fee has been determined as follows:

- a) The franchise permit fee rate for Nursing Homes described in ORC section 3721.511(A)(1)(a) and (b) is reduced to zero;
- b) Nursing facilities with more than 200 licensed or registered beds that are also certified for participation in Medicaid are assessed a franchise permit fee rate of \$11.52 per bed day for the certified beds up to 200 and \$9.37/bed day for certified beds in excess of 200;
- c) All other beds are assessed at a franchise permit fee rate of \$11.52 per bed day.

The quarterly installments, in the amounts specified on the enclosed assessment, are due on or before December 15, 2011, February 14, 2012, May 15, 2012, and August 14, 2012. Enclosed with this letter are:

- 1) the nursing home FPF annual assessment notice for state fiscal year 2012
- 2) instructions for submitting payment; and
- 3) instructions for requesting an appeal.

In accordance with ORC Section 3721.531, the Ohio Department of Job and Family Services (Department) shall redetermine the franchise permit fee if one or more bed surrenders occur during the period beginning on the first day of May of the preceding calendar year and ending on the first day of January of the calendar year. The Department will recalculate the franchise permit fee not later than February 15, 2012 and mail the notices by March 1, 2012.

It has been determined that the Fiscal Year (FY) 2011 franchise permit fee assessed exceeded the indirect guarantee percentage of the actual net patient revenue for all nursing homes and hospital long-term care units. The Department has recalculated the franchise permit fee rates for nursing facilities for FY11. Nursing facilities with more than 200 licensed or registered beds that are also certified for participation in Medicaid were originally assessed a franchise permit fee rate of \$12.00/bed day for the licensed beds that are not certified and the first 200 certified beds and \$9.81 per day for certified beds in excess of 200. All other nursing homes were assessed a franchise permit fee rate of \$12.00 per bed day. The recalculated rates are \$9.28 per bed day for certified beds in excess of 200 and \$11.35 per bed day for all other licensed or registered beds. The refund amount for your facility has been reflected in the amount due in the total installment due for the FY12, first quarter.

Please note that, if a facility fails to make a franchise fee payment when due, ODJFS may hold vendor payments until the franchise fee payment is made in full, offset vendor payments in amount an equal to the franchise fee owed

or terminate the facility's Medicaid provider agreement. Vendor payments may be offset without prior notice to the facility or an adjudication order under chapter 119 of the Revised Code.

Requests will be honored if they are submitted properly and received by ODJFS **no later than fifteen days after the postmark of this notice**. To properly request an appeal, please complete the following steps:
 - 1) Prepare a document listing the facility name, provider fee number and county. State the reason for the appeal and include the number of licensed beds in your facility on May 1, 2011 that are subject to the Nursing Home FPF. List the contact person's phone number and address if different from the facility's address.Submit the written appeal request to:
